General:

1. All coaching appointments (including head coaches & assistant coaches) shall expire on December 31<sup>st</sup> of each year, or at the conclusion of the annual league banquet,
2. All coaches must be reappointed, annually,
3. At the recommendation of the HYFC Football & Cheerleading Directors, the HYFC Executive Board of Directors shall approve & appoint the Head & Assistant Coaches for all teams,
4. All adults connected with Hudson Youth Football & Cheerleading shall be of unquestionable moral character and shall serve on a non-compensated basis,
5. All team personnel will be required to submit to a personal record check (CORI) by local authorities,
6. Any person found arrested on a charge involving moral turpitude or related offenses shall be deemed ineligible to serve in any coaching capacity,

Coaching Requirements:

1. Coaches must be at least 21 years old by the start of the season, August 1<sup>st</sup> (Assistant coaches must be at least 18 years old),
2. The position of coach shall be open to any responsible adult with sufficient interest in the game to study and develop teaching ability,
3. Each coach must show satisfactory character & sincerity of purpose to be a proper influence upon young Children,
4. Coaches must be real sportsmen who embody the best qualities of leadership and by their own example plant the attitude, ideals, and principles of sportsmanship and fair play into the minds of youth,
5. All coaches must attend a coaching clinic sponsored by the highest local authority, annually,
6. A coach may be asked to resign her/his position or be replaced, whenever, in the opinion of the HYFC Executive Board, The coach is not capable of handling young children or cannot properly assume the duties of and responsibilities required for this position,
7. All Head Coaches shall be directly responsible for actions involving himself, assistants, and players,
8. All Head Coaches shall be responsible for their team's support of all league fundraising activities, and
9. All Head Coaches shall be responsible for equipment issuance, equipment maintenance, and equipment collection.
